LAMOILLE COUNTY'S HEALTHCARE PROVIDERS WORK TOGETHER TO DELIVER OUTSTANDING AND COMPASSIONATE CARE

Most of us have visited a hospital at some point in our lives. We take a fall or break a bone, we go to the hospital. We get sick in the middle of the night, we go to the hospital. We notice a lump where there wasn't a lump before, we go to the hospital. From our earliest days we learn that the hospital is a safe place with dedicated and compassionate people who are trained to take care of us. And when that hospital happens to be located in Morrisville, Vermont, we know that one way or another, everything will be okay. And the reason it will be okay is because of Copley's collaborative approach to healthcare and its longstanding relationships with other community providers and businesses.

"Unlike many hospitals, Copley doesn't play silo games," says Mike Feulner, Copley's Board Liaison with Lamoille County Mental Health Services (LCMHS). "They don't approach medical care from a 'what's best for us' point of view. They approach it from a 'what's best for the community' angle. This means that when someone shows up at the ER, Copley looks at the person's whole picture. Do they see signs of mental illness? Has someone been evicted from their home? Is there evidence of substance abuse? Domestic abuse? Poverty? And when they do see symptoms of problems that are clearly deeper than a broken bone, they reach out to us - and to their other partners - to provide the care that each patient needs."

There are other important collaborations, including with Lamoille Health Partners and Tamarack Family Medicine, whose providers share hundreds of patients with Copley providers. There is the relationship with the Manor, a nursing home across the street from Copley. Then there's Lamoille Home Health & Hospice (LHHH), a nonprofit homecare and hospice agency that provides skilled nursing, rehabilitative therapies, wellness services, telemedicine, and long-term care, whose collaboration with Copley provides significant benefits to both organizations and the greater community.

"We meet with Copley five days a week to do discharge planning for patients who need additional care when they leave the hospital," says Kathy Demars, RN, Copley Trustee, Chair of Copley's Foundation Committee, and Executive Director of LHHH. "For some it might mean physical therapy, for others it could be meal preparation or ongoing medical care. Our job is to make sure patients get the care they need once they're back in their homes.

The collaboration with Copley makes everything come together."

"For example," she continued, "Copley shares its chaplain with us several times a week; we use their teaching lab to train our LNAs; they lend us their expertise when we have questions about follow up medical care; they loan us supplies, offer training, and even invite us to their food trucks as a way for staff from both organizations to get to know one another. It's an amazing community collaboration and it ensures an almost seamless transition for patients who are going home or re-entering the community after a medical event."

Erica Scott, Board President of the Lamoille Area Cancer Network (LACN), a nonprofit that gives grants to locals undergoing cancer treatment, Assistant Director at Lamoille Home Health & Hospice, and a member of Copley's Foundation Committee, had equally positive things to say about Copley's care and collaboration efforts. "As the local hospital, Copley provides wonderful care for patients going through cancer treatment," she said. "The family atmosphere, the compassionate care, and the growing number of services they offer really make a huge difference for people who are dealing with cancer. We constantly hear from patients how wonderful Copley is and how grateful they are for the care they receive."

But, the collaborations aren't all related to medical care. Jenna's Promise Roasting Co., a program of Jenna's Promise in Johnson, is Copley's exclusive coffee vendor. Photo Co-op artists from River Arts display their work in the Hospital's art gallery. This summer, after historic rain and flooding, N.A. Manosh had their potable water tanker and hauler trucks at Copley within hours of the 'Do Not Drink' notice being issued. Manosh's support allowed Copley to operate at close to normal under extremely challenging circumstances.

"As a small rural community, we have to take care of one another," said CEO Joseph Woodin. "By partnering with other care providers in the area, we not only make sure our patients get the best quality care they need, but we create efficiencies which, in turn, help bring the cost of healthcare down. We're fortunate here in Lamoille County to have such high-quality support services and, working together, we can make a real difference in people's lives."

LETTER FROM THE BOARD CHAIR

TO THE COPLEY COMMUNITY



In its 91st year of operation, Copley Hospital did what it has always done best: provide high quality and compassionate care to everyone who walked through its doors. This amazing little hospital has weathered good times and bad over those years. We are not especially wealthy, located in the heart of a metropolitan ara, or attached to a university, but we are generously supported by a community that understands the value and importance of maintaining a high-quality community hospital. Everything you will read about in this year's report reflects your commitment, dedication, and generosity, and we are profoundly grateful.

Three pieces of good news that come immediately to mind as I look back over the year are: the groundbreaking for our new medical office building in Waterbury, which will increase our ability to provide orthopedic services and treatment to an ever-growing number of Vermonters, vacationers, and second home owners; our growing women's

healthcare services, including new stereotactic breast biopsy equipment that will allow us to better diagnose and treat patients close to home; and the renovation and expansion of our Infusion Center, which will greatly ease the burden on patients and families requiring this specialized type of care. All three of these new initiatives help expand the important healthcare services we can offer here in Lamoille County, and all three were made possible thanks to your generous support.

The year 2023 posed challenges for Copley and the healthcare industry. Staffing shortages - nurses in particular - continue to be an issue, requiring us to spend additional funds to bring in outside help. Inflation, which has hit our industry especially hard, has forced us to spend more than we have traditionally budgeted for essential equipment and supplies. And a limited ability to increase our rates and fees, which are set by the Green Mountain Care Board (GMCB), means we need to look for additional ways to control costs and expenses. That said, Copley always finds creative ways to do more with less. The GMCB essentially said as much. And, while that certainly isn't our ideal budget model, I am always in awe of what our doctors, nurses, techs, and support staff are able to accomplish. People at Copley pitch in to help one another. They take on additional responsibilities - often without even being asked, and the result of their commitment is a work environment that makes people feel welcome and appreciated. No wonder we have employees who have worked here for 25, 30, and even 50 years (see page 17 for notable anniversaries).

But 'Team Copley' doesn't end there. Spend a little time walking our halls or strolling around our campus and you'll meet volunteers (of all ages) who assist our staff in patient care areas, offer administrative help, and greet visitors. (See the facing page for information about volunteers at Copley and to meet several volunteers.) Look a little more closely and you see the environmental services staff who keep this place looking beautiful, the kitchen staff who keep us well nourished, and so many others who work behind the scenes to make this place the destination hospital it is becoming.

These are challenging times for healthcare and there are no simple answers. But at Copley Hospital - as we have done for the past 91 years - we will continue to move forward, expanding our services and providing the highest quality healthcare to the patients and families who depend on us. And based on the grateful letters we receive; the accolades on social media; and the feedback I hear in the community, I am confident that we will weather whatever storms may come our way. It is a privilege to serve on your Board, and I am grateful for the opportunity to be a part of this wonderful organization.

LETTER FROM THE CEO

TEAM COPLEY GOING STRONG



It is my privilege and pleasure to share with you this Annual Report for the fiscal year ending September 2023, and to highlight both our numerous achievements and ongoing challenges. It was an extremely busy year here at Copley, and I could not be prouder of our entire medical team, support

staff, volunteers, and everyone associated with this truly amazing hospital. Year after year, you show up, go beyond what is asked of you, and get the job done.

In this report you will read about many upgrades and advances - from our new stereotactic breast biopsy equipment and new stress testing technology in our cardiology area to a new CT Scanner and a fully renovated CSR (Central Sterile Reprocessing) area. We broke ground on a new medical office building in Waterbury to accommodate our growing demand for orthopedic services, and we were named a "best performing critical access hospital for 2023" - the only hospital in Vermont to earn that rating. But advances and upgrades like this are a double-edged sword. As we become the "go-to" medical center for more and more Vermonters, we are reminded that our rates are among the lowest in the state. For example, the cost of getting a CT Scan in Vermont can range between \$1,600 to over \$5,000 - for the exact same service - depending on which hospital you go to. Unfortunately, we're the ones charging \$1,600.

It is essential, not only for us to continue providing the healthcare our communities need and deserve, but also for us to remain fiscally solvent, that we be allowed to bring our rates more in line with our sister hospitals across the state. To that end, we requested a 15 percent rate increase from the Green Mountain Care Board for the coming fiscal year, but we were granted only eight percent. When set next to the rate increases approved for other hospitals, our rates remain at or close to the bottom. Until we can charge appropriate fees for our services - fees that reflect our true cost of providing them - we will constantly be fighting an uphill battle.

That said, we continue to invest in our physical plant, in our practices, in our IT infrastructure, and in new

programs, not only to remain competitive, and not only to manage and control costs, but also to offer our patients and families the absolute best and most advanced medical care possible. Examples of this include the new equipment, technology, and campus expansions but also our nurse residency graduate program and nursing assistant education program, which are helping us attract, train, and retain nurses at a time when nursing shortages are impacting hospitals across the country. And all of this is made possible through the generous donations of our longtime supporters. Anyone can sit in their office and write out a list of their challenges. What gives me such hope - and energy - is that Copley is blessed with a community of caring professionals and supporters who allow it to excel and advance despite those challenges.

We are very excited to report on the progress of our new medical office building in Waterbury. We broke ground this past fall and hope to complete the project in June of this year. When completed, it will be a second home to Mansfield Orthopaedics, which has been experiencing tremendous growth over the past few years. We are equally pleased with the progress of our expanded Infusion Center, which will allow us to care for patients who require these services comfortably and compassionately.

It is no secret that we wouldn't be who or where we are without the many volunteers who greet visitors, assist our medical staff, support at events, and who step up to take on whatever responsibilities present themselves. Our newly revived 'Friends of Copley' program is a testament to the people who embrace this hospital with both their hands and hearts, and our newly revitalized youth volunteer program is introducing young people to the opportunities available in the healthcare industry. When all is said and done, we are here, we are growing, and we are successful in large part because of our vibrant community connections. Part of being a community hospital is being deeply connected to and with the community, and I am thankful to live and work among such a unique and caring group of people.

As you'll see in the pages of this report, we continue to attract outstanding medical and administrative professionals who want to be a part of this special organization, and we continue to earn high ratings and accreditations from the auditors and organizations who

rate healthcare facilities. But, most importantly, we are constantly receiving letters, emails, and phone calls, or having conversations at the grocery store with people whose experience at Copley left them not only healed, but happy. Despite our challenges, we continue to do it right, and that speaks volumes about the people who work here.

As I reflect on the past year and on the years ahead, I am mindful of all we have accomplished, and I am confident we will meet and overcome any challenges that may come our way. But for now, I am simply grateful to reflect on what a privilege it is to serve as your CEO. And what makes it such a privilege - what makes it so satisfying - is working alongside the people who've chosen to work here, obtain healthcare here, and support our efforts. Together we are "Team Copley." And together, we will continue to do the good work entrusted to us.



As the sun went down over Caspian Lake on a warm July evening last summer, the 70 or so villagers of Greensboro, who'd gathered at the home of Francie and John Downing for a Copley Hospital friend-raiser, paused to appreciate the bucolic setting. While the world races along at a dizzying pace, quiet Greensboro - just 18 miles away - has remained almost immune to the march of time. Just ask Clive Gray, who's been living here full-time since 2002, and as a summer resident since 1934.

"When I think back on my earliest memories here," he says, "not much has changed. We still get everything we need from the Willey's Store, the lake is still the center of activity, the summer people return year after year, and Copley Hospital is ever at the ready to keep us patched up and going strong."

Clive, who serves on Copley's Foundation Committee, will also tell you about something else that hasn't changed in 90 years, and that's Greensboro's deep appreciation for, and reliance on, Copley Hospital.

"Copley is so important to this community," he says. "Most of us have gone there for one reason or another over the years, and it's always great to be greeted by familiar faces. I had surgery there back in 1986, and I remember looking at the mountains and thinking 'what a delightful spot this is' and not being in any particular hurry to get discharged. The people who've taken care of me at Copley are some of the nicest - and most talented - people I have ever met."

Francie Downing, also a member of the Foundation Committee and one of Copley's most enthusiastic ambassadors, hosted the gathering on that warm July evening because, as she puts it: "Greensboro needs Copley Hospital. As my husband and I grow older and our energetic grandchildren visit us, it is very comforting to know that there is a local hospital just down the road that delivers high quality emergency care. Several years ago, on a Friday afternoon, I fell while working in my garden. I spent that night in the hospital, and I received excellent medical care. Greensboro relies on Copley Hospital

in so many ways and the truth is, Copley relies on the people of Greensboro. It is so important for our community to support Copley, and it is a privilege for me to be a part of that process."

Mike Cassidy came to Greensboro in 1999 and could rattle off a long list of reasons for his family's visits to Copley. But his primary one - in addition to the medical care they have received - is the people. "They are simply the most compassionate people you will ever meet. From the moment you walk in the door, someone is there to help you and make sure you're comfortable. You honestly feel like you're among family." For Mike, serving on the Foundation Committee is just one of the ways he can give something back.

Tod Mann, a summer resident of Greensboro for the past 57 years, has his own reasons for supporting Copley. "I married my wife, Gwen, back in 1966," he says, chuckling. "She belonged to one of the old Greensboro clans, and I was an outsider hoping to gain admission. From early on, we all understood the value of Copley Hospital. My grandson was born there, and, over the years, our family has had many positive interactions with the people there. For years, there was a photo of our son and his wife with their newborn on the wall. That underscores the family connections and atmosphere."

Tod serves on the Foundation Committee to ensure Copley gets the support it needs to exist and to thrive. "Copley is woven into the fabric of Lamoille County," he says. "Just ask anyone who's broken a leg on the ski slopes, delivered a baby, or been rushed to the ER in the middle of the night."

And finally, there's Lynn Stegner: author, teacher, Foundation Committee member, and grateful patient. Lynn's connection to Copley - outside of her visits over the years for bumps, scrapes, and bruises - deepened when she needed someone to look at a chronic foot issue.

"I had foot surgery twenty years ago," she said, "and it never quite healed correctly. I live in San Francisco, near some of the most cutting-edge hospitals in the country, and no one could figure out the problem. Then I came to Mansfield Orthopaedics and Dr. Bryan Monier was not only able to tell me what was wrong, but also how to correct it. But to make his diagnosis, he had to send me elsewhere for an MRI. The whole time I kept thinking, here's this world class orthopaedic center attracting patients from across the country, and they don't have a decent MRI machine. I decided then and there to get involved with fundraising."

Through her connections in Greensboro, Lynn played a big role in securing funding for Copley's new MRI suite. "I have always believed that health precedes happiness," she says. "I was so grateful to Dr. Monier and to Mansfield Orthopaedics for their professionalism, knowledge, and care that I just wanted to give something back. Serving on the Foundation Committee gives me that opportunity, and the opportunity to play a small role in making sure Copley is always there for the people of Greensboro - and vice versa."




JANUARY

PATIENT PROFILE: JAY PILCER



"I am happier on the hill than I am anywhere else," said Jay Pilcer of South Burlington, Vermont - with the hill being Mount Mansfield at Stowe Mountain Resort, where Jay has skied for over 50 years. To describe Jay as active is an understatement. In addition to skiing and his busy day job selling IT services across New England, Jay plays golf, paddleboards, surfs, skins, and bikes.

Jay participated in Copley's 3rd Gravel Moxie in October of 2023, and after the ride, stood up to share a story about his connection to Copley Hospital. As he spoke, he pointed to his shoulders and one of his knees - left, right, down. In 2013, Jay had his right knee replaced by Dr. Bryan Huber at Mansfield Orthopaedics. Then, in 2020 and 2022, Dr. John Macy repaired his left then his right rotator cuffs.

By the time Jay decided to get his knee replaced, he had become accustomed to living with severe pain. "It was bone on bone in my knee joint. I'd be waiting to get on the ski lift and have to put 100% of my weight on my poles to compensate." Jay says that when the pain becomes this bad and affects your everyday life, you do the surgery. He did his research and chose Mansfield Orthopaedics.

Jay says that for his initial go-around with Mansfield Orthopaedics - for his knee - he felt for the first time in his life like an educated patient and consumer. "Copley

providers take their time. I was educated on the pros and cons of surgery and what my options and possible outcomes were. People want to trust their doctors, and they want to understand the outlook. Will I ever ski again, walk again? My providers spent time with me. You just don't get this other places."

Jay says he did not feel nervous at all going into surgery. A bonus for Jay was the get-well card signed by every member of the surgical team – a Copley OR tradition – which he received a few days after his shoulder procedure in 2022. "It is such a nice touch," Jay said. Jay was so pleased with the experience and the outcome of the surgery that, when he could safely walk and get around, he hand-delivered platters of food from the Edelweiss Deli in Stowe to the OR and surgical staff.

Jay grew up skiing in Stowe with his parents. Today, at 66, he is aware that his dad was not doing nearly as much at 66 that Jay does. "We have a more mobile society, and we all want to keep doing what we're doing," he said. "Who is keeping us able to do this is the orthopaedic surgeons at Mansfield Orthopaedics and Copley Hospital. To be able to come back and ski three months after my surgery and, by six months, to ski as well - if not as hard - as I ever had is a miracle."




